### **Application for Confirmation Letter**

- A. Requirements for application of Metrobank Confirmation Letter for CPA Bank Service Fee is NTD\$ 300<sub>z</sub> plus NTD\$ 100 for each additional information requested.
- 1. **Deposits**: include current account, passbook account, time deposit, foreign currency deposit, and others (please specify).
- 2. Bank discount and loans: include banking discount, overdraft, short-term loans, medium-term loans, long-term loans, advance payment for domestic bill, and only exclude purchase of account receivable.
- 3. Account receivable underwriting.
- **4. Issued Letter of Credit:** (balance unused), include time/usance credit, sight credit.
- **5.** Acceptance and guaranty: include bill acceptance, commercial paper guaranty, tariff; cargo with charge account guaranty, corporate bond guaranty, letter of guaranty and secured L/C, and others (please specify).
- **6. Derivative financial products:** include exchange forward contract, option, and others (please specify).
- **7. Other items:** such as marketable securities or bills with custody trust and guaranty, c/o instrument, trust and others (please specify).

#### **B.** Payment Procedure:
